Insurance Information

The plan has contracts with United Of Omaha Life Insurance Company, Unitedhealthcare Insurance Company, Care-Plus Dental Plans Inc, United Of Omaha Life Insurance Company, United Of Omaha Life Insurance Company, National Vision Administrators Llc and United Of Omaha Life Insurance Company to pay dental, vision, life insurance, long-term disability, VOLUNTARY AD&D, ACCIDENT PROTECTION PLAN AND CRITICAL ILLNESS, AD&D and VOLUNTARY LIFE claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2020 were \$939,927.
