



Well-being Program Requirements for 2025

All Associates and spouses/domestic partners are eligible to participate in Grande's well-being program, Asset Health. In 2025, Associates and spouses are required to complete a biometric screening OR an annual wellness exam AND earn 750 points through your choice of approved wellness activities by December 1, 2025, to receive a discount on your medical premium for the 2026 plan year. Medical premium discount will remain \$35/paycheck for Associate + additional \$20/paycheck for spouse/domestic partner participation.

Associates and spouses should follow the following guidelines to complete their biometric screening and annual wellness exam.

Biometric Screening

Dates

Biometric screening must take place between December 2, 2024 and November 28, 2025. To qualify for the incentive, a physician form must be submitted no later than December 1, 2025.

Biometric Screening Appointment

Your appointment can be completed at one of the Grande on-site clinics or completed with an outside Primary Care Provider (PCP). To schedule an appointment with the Grande clinic, call 920-907-3922 to schedule an appointment.

If your appointment is completed with the clinic, your biometric results will be submitted to Asset Health for points within two weeks of screening.

If your appointment is completed with a PCP, a physician form must be brought with you to the appointment and completed by your PCP. Form needs to be turned back in on portal. See detailed directions below.





Points Receive 250 points upon completion of biometric screening. Receive up to 210 points for meeting healthy measures (auto-awarded) BMI, BP, Glucose, LDL, HDL, Tobacco

Please follow the below directions to find the physician form on Asset Health portal.

Once you log into Asset Health, you can locate the Physician form on the bottom of the home page under 'Quick Links'. Download, print and bring this form with you to your appointment.



Once you have received a completed physician form, you will need to upload it to Asset Health. Locate the 'Physician Form Upload' drop box. Browse for saved document and upload the completed form.

Once you complete your biometric screening, you will find your results on the Asset Health portal.

- 1. On the dashboard, click on 'Health Measures'.
- 2. The biometrics "ring" will light up green when complete and uploaded.
- 3. Biometric Data will show results for each test.

Annual Wellness Exam

The annual wellness exam must take place between December 2, 2024 and November 28, 2025. For Associates and spouses to receive points for the annual wellness exam, there are some differences for those enrolled and not enrolled in Grande's medical plan, as noted below. Once your annual wellness exam is completed, you will receive 250 points.
